# **INTRODUCTION**

Institute of Forest Productivity (IFP), Ranchi is a research institute functioning under the aegis of the Indian Council of Forestry Research and Education (ICFRE), Dehradun, an apex body in the national forestry research system. The institute caters to the forestry research needs of the eastern region of the country under its jurisdiction for the states of Jharkhand, West Bengal and Bihar, encompassing more than 42000 Km<sup>2</sup> of forest area falling under six agro-ecological zones and having six main forest types. Since coming into existence as a full fledged research institute in 1993, the institute has initiated steady steps to address a wide range of problems borne and accentuated by vast stretches of degraded forests, dwindling species richness especially those of medicinal plants, bamboos and canes; heavy pressure of mining and numeral industrial development processes.

The main predecessor of the Institute of Forest Productivity was Directorate of Lac Development (under the Forest Research Institute, Dehradun from 1987 to 1993) and has a legendary past in, that it is the successor of Indian Lac Cess Committee that was formed in pre independence days in 1935 when the commercial significance of lac was well recognized. With re-organization of forestry research and education in India and formation of the Indian Council of Forestry Research and Education (ICFRE), the Institute of Forest Productivity was allocated responsibilities to undertake forestry research in the states of Jharkhand, Bihar and West Bengal.

The Institute also functions as one of the Study Centre of the FRI Deemed University, Dehradun for M.Sc students and Ph.D research scholars. To facilitate the R&D works the institute is equipped with a library, video conferencing facility, soil laboratory, molecular biology laboratory, medicinal garden and bamboosetum.

# **MISSION**

As an institution under the aegis of Indian Council of Forestry Research and Education (ICFRE), Dehradun, the institute endeavors to fulfill and achieve the mission of its Council, as follows:

- 1. Updating, developing and providing knowledge, skill, technology and experiences to support development in forestry sector in accordance with priorities of National Forestry Research Plan (NFRP) and National Forest Policy for sustainable forest development.
- 2. To undertake, coordinate, promote and aid forestry research, extension and education.
- 3. Developing packages of technology and practices according to the needs of different stakeholders so as to contribute towards sustainability and promote these technologies through aggressive marketing.

- 2. To provide scientific advice to the central and state governments aiding informed decision making in matters of national and regional importance and international commitments and to address forestry research needs.
- 3. To provide technical assistance and material support to states, forest dependent communities, forest based industries, tree & NTFP growers and other stakeholders in their forestry based programmes for conservation and sustainable use of forest resources.
- 4. To undertake research in silviculture and forest management for development of natural and artificial regeneration practices, including nursery & plantation techniques.
- 5. To develop appropriate cultivation, harvest and postharvest techniques for important NTFP and lesser known tree species.
- 6. To undertake research on forest productivity, eco-restoration and rehabilitation of mined out areas & other stressed/degraded/difficult sites.
- 7. To undertake research on genetic improvement for productivity enhancement of economically important species.
- 8. To undertake research and knowledge management on various aspects of forests, viz., forest soils, invasive species, forest fires, insect pests and diseases.
- 9. To develop, upscale, disseminate and share of appropriate technologies to end-users through innovative extension strategies and capacity building programmes.
- 10. To undertake all such activities as necessary, incidental and conducive to attainment of the objectives of the Council.

# **CORE RESEARCH AREAS**

- 1. Ecological reclamation of mined overburdens and stressed sites.
- 2. NTFPs and cash crops of forest origin including Lac and Tasar.
- 3. Development of agro-forestry models suitable for different agro-climatic zones and cropping patterns in eastern India.
- 4. Community based natural resources management and documentation of indigenous traditional knowledge.
- 5. Tree improvement programme employing molecular and biotechnological tools and vegetative propagation approaches.

#### 1. SILVICULTURE AND FOREST MANAGEMENT DIVISION

The division conducts research on the dynamics of tree growth for enhanced productivity in important forestry species of the region, development of modern nursery practices and macropropagation protocols for a number of forestry and medicinal plant species. The division regularly imparts training and education in various aspects of plant molecular biology, tree physiology and biochemistry, modern nursery techniques, medicinal plant cultivation and clonal propagation to various stakeholders.

# Mandate of Silviculture and Forest Management Division

- Resource assessment and sustainable management of important forest species.
- Development of nursery and plantation techniques of important forest tree species.
- Research on seed collection, processing and storage of important forestry species.
- Phyto-chemical evaluation of NTFPs including medicinal plants for their sustainable utilization and income generation.
- Development of appropriate cultivation and harvesting practices of important NTFPs for livelihood generation.
- Development of post harvest and value addition techniques of NTFPs.
- To conduct research, extension and education activities for enhancement of productivity of NWFP species and cash crops of forest origin.

# 2. GENETICS AND TREE IMPROVEMENT DIVISION

The division is engaged in the development of micro and macro propagation protocols of important tree species, bamboos and medicinal plants. Tree improvement research work on oil-yielding trees such as *Derris indica*, *Madhuca latifolia* and *Jatropha curcas* are also being carried out. Variability/ productivity and growth dynamics studies in relation to soil properties in bamboo species of Bihar, Jharkhand and West Bengal are underway. Assessment of Genotype X Environment Interactions in *Eucalyptus tereticornis Eucalyptus camaldulensis*, *Melia dubia*, *Dalbergia latifolia* and *Populus deltoids* is also being done.

### 3. FOREST ECOLOGY AND CLIMATE CHANGE DIVISION

The Forest Ecology and Climate Change division of the institute is a sister concern of Forest Research Institute, Dehradun where the study of forest ecology started since 1906 in India. The FECC division of the institute is a pioneer in the field of ecological studies in Eastern and Central India. Study of climate change, change in biodiversity, threat of invasive species, shift of species, development of ecological models for eco-restoration of mined out areas, especially iron ore and coal mines are some of the works carried out by the division. In recent years, the division has carried out Environmental Impact Assessment for different Stakeholders of the country. The study of above ground and below ground biodiversity, soil vegetation interrelationships, along with documentation of traditional indigenous knowledge for natural resource management using latest available technologies of remote sensing, geo-informatics, long-term earth observation data and spatial database management are regular activities of the division. The division has a full flagged ISO certified soil laboratory for testing on basic parameters, major nutrients, micro nutrients and heavy metals present in soil.

# RESEARCH AND EXTENSION CENTRES

# 1. Forestry Research and Extension Centre (FREC), Hajipur, Bihar

The centre was established for providing technology and services to the Environment & Forest Department, Govt. of Bihar for implementation of Agroforestry component of "Integrated Community Based Forest management Project in Bihar" funded by Planning Commission, GoI under the Special Plan for Bihar Component of Rashtriya Sam Vikas Yojana. Agroforestry component was implemented by the Institute. In Phase I, project was implemented in Vaishali district with the plantation target of 76 lacs Poplar as the major species.

# 2. Environmental Research Station (ERS), Sukna, West Bengal

The centre is well equipped for different data recording facility in selected watersheds. The Meteorological station and observatories at Sonada and Sukna is having Hydro-meteorological recording facilities in Darjeeling district of West Bengal. The centre has also developed an herbal garden and propagation centre for production of QPMs of medicinal plants and creating awareness for end users.

# 3. Forest Research Centre (FRC), Mandar, Ranchi

It is well equipped with soil testing and biochemistry laboratories. The modern nursery facilities with mist chambers, composting units is also available in the premise of Mandar Research Centre. The centre has vast experimental area with 24.32 hectares comprising progeny trial of *Melia dubia* and other economically important tree species. Recently, big bamboo nursery under the scheme of National Bamboo Mission has been initiated with propagation of superior bamboo stock and various demonstration trials.

# 4. Nucleus Brood Lac Farm, Chandwa, Latehar

The Nucleus Brood Lac Farm in 17 hectares of land at Chandwa village in Latehar district serves as training cum demonstration centre for training on improved methods of Lac cultivation. Apart from trainings and demonstrations, publicity materials constituting of brochures, pamphlets, handouts and booklets on improved methods of lac cultivation practices are distributed for ready reference.


